- 1. All items are sold "AS IS, WHERE IS" with all faults. There are no warranties or representations of merchantability, of fitness, nor of any other kind, express or implied. All items are available for your examination prior to bidding.
- 2. All property is sold "AS IS, WHERE IS" and neither ELEGANCE AUCTION nor the consignor makes any warranties or representations of any kind or nature with respect to property or its value, and in no event shall be responsible for the correctness of description, genuineness, attribution, provenance, authenticity, authorship, completeness, condition of property or estimate of value. No

statement (oral or written) in this catalog, at the sale, or elsewhere shall be deemed such a warranty or representation, or any assumption of responsibility. All measurements are approximate.

- 3. By placing a bid, either in person, by phone, absentee or via the Internet, you signify that you have examined the items as fully as you desire to or that you have chosen not to examine them. If you require absolute certainty in all areas of authenticity, and the results of your evaluation leave uncertainty in your mind, we recommend you have an expert examine the lot for you or do not bid on the item in question.
- 4. The successful bidder is the highest bidder acknowledged by the auctioneer. - 10. If we are prevented by fire, theft, or any other reasons whatsoever from delivering any property to the buyer, our liability shall be limited to the sum actually paid, by the buyer for such property.
- 11. The auctioneer reserves the right to withdraw any lot at any time before the auction without liability.
- 12. The auctioneer reserves the right to reject any bid not commensurate with the value of the property offered.
- 13. If any applicable conditions herein are not complied with by the purchaser, in addition to other remedies available to it by law, including without limitation the right to hold the purchaser liable for the total purchase price, ELEGANCE AUCTION at its option may either (a) cancel the sale, retaining as liquidated damages all payments made by the purchaser or (b) resell the property at public auction without reserve or minimum selling price, and the purchaser will be liable for any deficiency and costs, including handling charges, expenses of both sales, the commission on both sales at regular rates, all other charges due hereunder and incidental damages.
- 14. In the unlikely event we lose our internet connection, ELEGANCE AUCTION reserves the right in its sole and absolute discretion to cancel the remainder of the auction.
